This Addendum No. 1 forms a part of the Contract Documents and as such, all proposers should acknowledge it in the quote documents. Failure to do so could result in the rejection of your quote.

**QUESTIONS AND ANSWERS:**

1. **QUESTION:** New doors call for electric strike retraction, if the new doors are to operate simultaneously what type of locking mechanism is required?  
  
1. **ANSWER:** *Both double doors require Electrimagnetic locks to meet or exceed UL1034 and BHMA 1500 lb. hold force requirements.*
2. **QUESTION:** Would like to know what size doors you intending on having?  
  
2. **ANSWER:** *Two (2) full opening double doors. The openings are roughly 4'-11" x 6'-8", contractor must verify dimensions in the field.*
3. **QUESTION:** To control the door power operators you have 1 push button on the outside of building and one key card located in the vestibule. A) Is your intent to have a separate control paddle inside the building to exit? B) Is the card reader going to release whatever locking mechanism and activate the interior door?  
  
3. **ANSWER:**     A) Yes (see Plan A2).  
                      B) Yes.

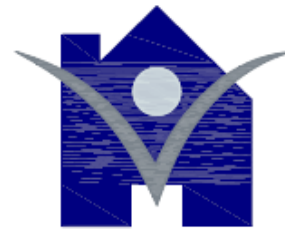

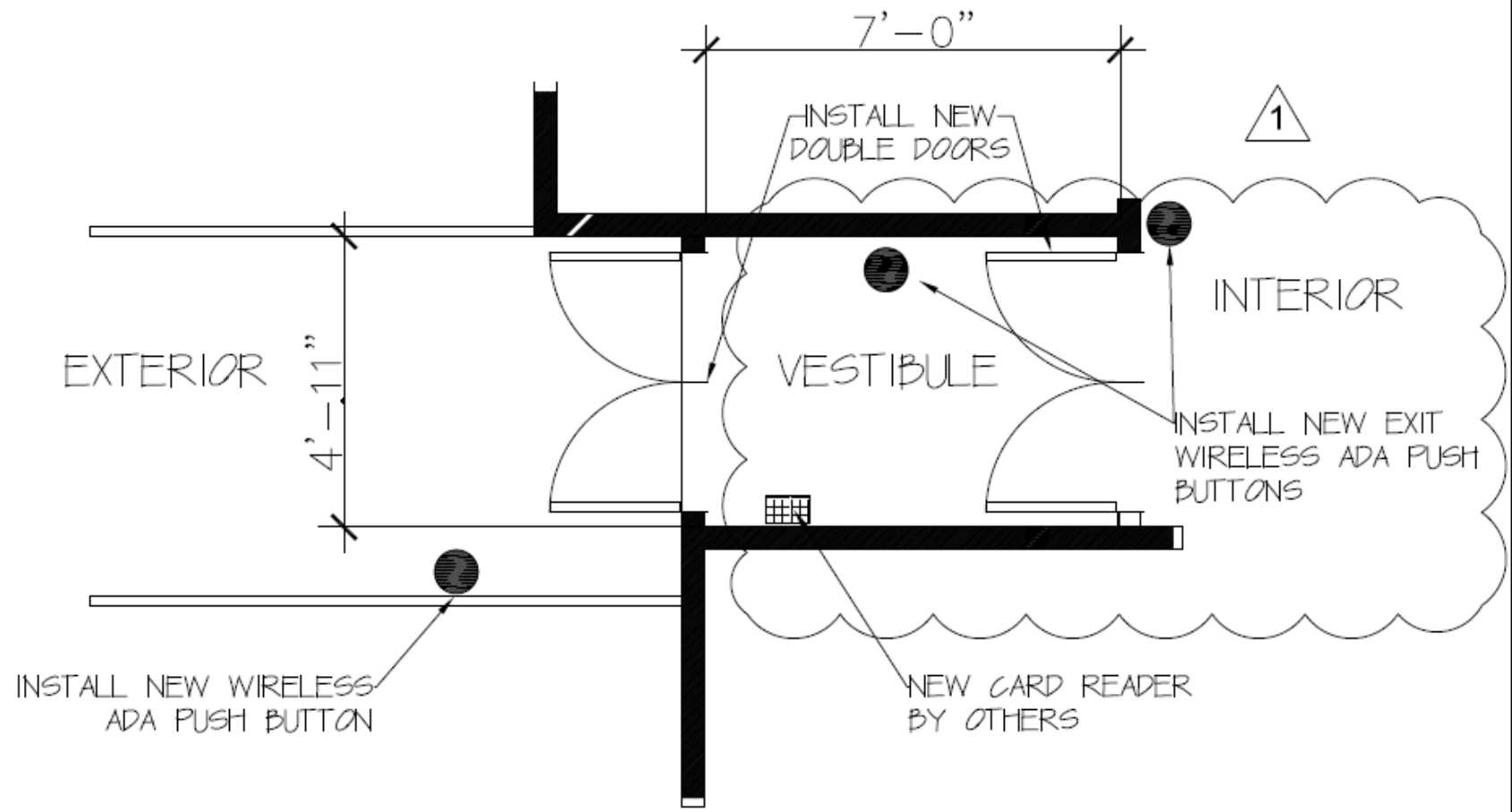
