### ITEM NO. 1: EXTENSION OF BID DEADLINE

The bid deadline is extended to 2:00pm, Monday, May 6th, 2024.

## **ITEM NO. 2:** QUESTIONS FOR CLARIFICATION

Please see below for responses to inquiries:

- 1. Please clarify if the contractor will perform asbestos surveying / sampling and analysis under this contract, or if WHA will perform sampling and the contractor be responsible for analysis only.
  - A. The contractor will perform asbestos surveying / sampling and analysis under this contract.

- 2. Will the contractor perform asbestos air sampling and asbestos bulk sampling under this contract?
  - A. The contractor will perform asbestos air sampling and asbestos bulk sampling under this contract.
- 3. Please clarify if the 'Sample Testing' rate listed in the bid price form is inclusive of labor and travel expenses for sample collection and analysis.
  - A. Please refer to the enclosed revised bid price form.

The updated form distinguishes between Bulk Sampling and Air Clearance Sampling, with pricing inclusive of all expenses except for lab fees. The lab cost is treated separately and comprises solely of the fee charged by the lab, along with a 5% markup. Annually, approximately 520 residential units are tested (PLM), with an average of 12.5 samples collected per site. Each visit covers approximately 5 sites and on an average of 3 days per week. Additionally, around 200 residential units are tested (PCM) annually, involving an average of 2-3 samples collected per site. An average of 16 abatements are performed monthly. A turnaround time of 24 hours is preferred.

- 4. Please clarify which analytical method (PLM, PCM, TEM, etc.) is requested in the 'Sample Testing' row of the bid price form.
  - A. PLM and PCM. Please see the enclosed revised bid price form.
- 5. Please clarify which analytical method (PLM, PCM, TEM, etc.) is requested in the 'Lab Cost' row of the bid price form.
  - A. Refer to #4 above.
- 6. Please clarify if the 'Lab Cost' row of the bid price form requests pricing inclusive of a 5% markup.
  - A. Yes
- 7. Please provide the number of task orders and the total value of the contract over the previous term of the contract.
  - A. This is the 1<sup>st</sup> solicitation for a contract. Approximately 520 resident units are tested annually with an average of 12.5 samples per collection site. Each of these units is considered a task order. The contract will require a report for each tested location.
- 8. The RFP requests that bidders list all contracts within the past five (5) years that are of similar size, scope and dollar amount to this contract. Is it sufficient to provide four (4) references?
  - A. Yes, the WHA will accept 4 or more references of similar scope and size.
