Please see below for responses to inquiries:

Q1. If the Debarment/Suspension Form is required, will an Addendum be issued with the form?

A1. Yes. See the form attached below.

Q2. Who is presently the asbestos firm on contract?

A2. There is currently no vendor under contract.

Q3. Who is the asbestos consulting firm providing on-site monitoring for the project representing Worcester housing? And is it on-site monitoring and on-site air clearances?

A3. Ed Morgan – Asbestos Consultants is utilized as described in the question below.

Q4. Is the Asbestos Designer the same firm monitoring the project?

A4. For the purposes of this IFB there is no Asbestos Designer as this is not a contract for a single project. WHA samples all materials prior to demolition by our Asbestos Consultant. Once determined if the materials contained Asbestos, we would utilize this contract holder for remediation. If Air Clearance is required, Ed Morgan would work in conjunction with the winning bidder to perform air clearance as needed.
